



# Southwest Gas begins service

Southwest Gas' acquisition of CP National's natural gas operations in Henderson took effect at midnight, bringing uniformity to gas rates and service throughout southern Nevada.

"For too many years, thousands of gas customers in Henderson and Green Valley have paid higher gas rates than their neighbors who are served by Southwest Gas," said Kenny C. Guinn, Southwest chairman and chief executive officer. "But that's all over now. Beginning today, those customers will receive the same reasonable rates, top-quality service and local community support that our Southern Nevada customers have long enjoyed."

To help expedite regulatory approval of the acquisition, Southwest also agreed to a twoyear cap on géneral natural gas rates for all of its southern Nevada customers. Only increases or decreases in the cost of gas from Southwest's suppliers may be passed on to customers during that time.

"We're working hard to make the transition from CP National to Southwest as smooth as possible," Guinn said. "During the next 90 days, we'll be telling our new customers about the many programs and services we offer, and

## **Proposed hotel-casino** before planners Thursday

The proposed Wagon Wheel Hotel and Casino, which originally received its architectural approval on July 5, 1988, will be back before the Henderson Planning Commission at 7 p.m. Thursday.

An extension of time for the architectural review will be requested to allow the project's developers more time to find financing.

According to the city staff's report, the applicant, Magna Leisure Partnership, is having trouble finding financing for the gaming property.

"The applicant has informed staff that debt funding of a gaming property in the financial markets today is literally impossible. He has stated that, at the present time, many of the larger hotel/casino properties are experiencing very difficult times and many banks are reluctant to finance start-up hotel/casino projects."

applicant still believes this is a viable project and is requesting the additional extension to continue seeking financing," staff's report reads.

The project, if built, would be located at 2200 S. Boulder Highway, northeast of Boulder Highway and Roberts Road in the River Mountain neighborhood.

The planners will also:

· Discuss an extension of time for the Drake/Racetrack development consisting of 373 lots on 80 acres-located northwest of Racetrack Road and Burkholder Boulevard in the Foothills neighborhood. If built by Millennium Communities, Drake/Racetrack would have a density of 4.7 dwelling units per acre.

# Schools adjust as enrollment figures settle

**By Roy Theiss** News Staff Writer Every school except one in Henderson experienced some teaching changes after enrollment figures were sent to the Clark County School District last week.

The official date, known as count day, for the state's budget for school enrollment was Sept. 20, and every school had to submit an enrollment figure to the district.

The state provides the Clark County School District \$3,212 for each student. The school district is now auditing the numbers and has until Nov. 1 to submit the enrollment figures to the governor's office.

The teacher-to-student ratio for all elementary grades except first and second is staffed at 30 students to one teacher. At the first grade level the ratio is 16.5 to 1 and the second grade is 19 to 1. The school district tries to keep the ratio at the junior high school level at 28 to 1 and the senior high schools at 25.5 to 1.

A grade level will get a new teacher when they exceed the ratio but do not drop below 21 to 1 when the teacher is added.


Along with trying to get an accurate number for the budget, the school district has been reassigning teachers to other schools due to inaccurate projections. In April of each year, the school district projects the number of students who will be enrolling in each school in the fall.

Due to uncertain factors (more people moving into or out of anarea), the enrollment projections and the actual figures can either be as close as three students (C.T. Sewell Elementary School, for example) or off as much as 427 students (Green Valley High School.)

#### C.T. Sewell

C.T. Sewell Elementary had 803 students enrolled on count day. That is three more than what was projected and means there won't be any changing in teaching assignments.

"They came in right about on target so there won't be any changes for teachers," said Prinicpal David Mendelson, "It's nice not to have to go over to



someone and say you have to go because of the surplus, so we are going to send you somewhere else.'

**Green Valley High School** 

With an enrollment figure at 2,123 (up427), Green Valley High is experiencing the biggest changes in Henderson. Today,13 new teachers and one counselor started working. They reported in yesterday and had one day to get familiar with the new facility before taking on their new responsibilities. Virtually all the core areas are affected by the new teacher

addition. The English, social studies and physical education departments will add two teachers to their staff. The science and mathematics departments will pick up two and one-half teacher positions, respectively-one instructor will be teaching in both areas. education department will add one teacher to their staffs, respectively.

"There will be a little adjustment for the students, teachers and parents," said principal Caroll Johnston. "But this provides an opportunity to reduce the class size in most areas."

Johnston added that they still need help in computer and health classes but the school district didn't have anyone certified to fill the positions.

**Basic High School** 

Basic High School's enrollment figure of 2,155 is 75 pupils less than what the school district had projected. Basic lost five teachers, one assistant principal, one counselor and one secretary.

"It's real unfortunate because we are only down a small number," said principal Joanne Pughsley. "I could understand it if we were down a couple of hundred students."

Pughsley said the staff reduction affects all classes. She added that they have had to reschedule quite a few students in order to absorb the teacher loss.

#### **Brown Junior High School**

B. Mahlon Brown Junior High School came the closest to meeting the projected number of students at the secondary school level. They were five students fewer than the 820 school district anticipated.

Principal Emilio Fernandez had to reassign one seventh grade so-

## Letters section a great forum

Following a Page 1 story about the Burkholder middle school concept in the Home News, I received two letters critical of Lamping. I immediately disregarded one anonymous letter and published the

other one with the name of the writer withheld on request.


News policy is this: No anonymous letters will be printed, period. Writers must sign their name and provide a telephone number and address for verification purposes. Names will be withheld only if the reasons are compelling and the letter adds a clear, informed voice to the debate.

If printing the name of the letter writer will cause that person or his family harm, well, then that's a compelling reason.

After the letter was printed, a Burkholder teacher eloquently defended Lamping and the middle school concept in the next batch of letters. We have since received other letters, the negative ones anonymous and the positive ones signed.

What makes this case troubling is when a caller Friday said his child, a student at Burkholder, was approached by a teacher asking if that child's parent wrote the initial critical letter. I don't know if the incident is true, and if it is true, I cannot conclude that it is part of a kind of "witch-hunt" to smoke out the letter writer.

I just hope that it isn't true. I hope that the students, although they are ultimately what the discussion is about, are not pressured or

A newspaper's function is to inform, educate and to entertain, to be a watchdog of government-but also to provide a timely forum in which residents can bring to light and discuss issues that are important to the community.

# **King appears** in Justice Court

James Dee King appeared before Henderson Justice of the Peace Rodney Burr Monday for his initial arraignment on charges of killing two transients at a homeless camp in Henderson last month.

His arraignment was continued to Wednesday for confirmation of a public defender, according to a spokeswoman for Henderson Justice Court.

Bail was set at \$1 million, she said.

King, 46, is charged with two counts of murder for the Sept. 20 deaths of 44-year-old Chilton William Blakely and Bessie Maude Hathaway, 50. Both were shot to death apparently after confronting King as he allegedly tore apart the camp of another pair of transients, police said.

Henderson police captured King near Boulder Highway on the U.S. 95 cutoff to Searchlight after he fled the scene in a pickup truck.

#### King may have lived in Henderson for at least a year, according to people who had known him since before Christmas 1990. He apparently lived at a local motel until last Spring, when he left while his rent was paid up for several more weeks.

The proprieter said King admitted having trouble controlling himself while drunk, but seemed to keep his drinking under control while staying at the establishment.

He was living at a homeless camp northwest of Sunset Road and Pabco Road just inside Henderson's borders when the couple was killed, police said.

According to police, King had argued with two others at the site, accusing them of stealing some chairs. He returned to that campsite with a gun, but the pair had gone to a store, police said.

Blakely and Hathaway were shot to death when they came into that camp while the suspect was allegedly tearing apart a tent, police said.

## Man arrested for threatening wife


## **Circle K robber escapes**

## Storage shed burglars caught

Storage rooms at an apartment complex on Eastminister Court were rifled early Saturday morning, leading to the arrests of two young men accused of stealing property, according to the Henderson Police Department.

Police said Jason C. Salazar, 18, and a 17-year-old juvenile, both from Henderson, were arrested after fleeing from officers who observed them attempting to open a fifth storage shed, police said.

Officers were called to a burglary in progress at the Atlantic City Apartments shortly after 4 a.m. Saturday, an HPD press release stated.

One witness told police the suspects were "making trips from the scene [carrying property] into a nearby housing project." Witnesses also told police "the suspects had been prying open storage rooms and removing the contents."

Officers staked out the area, waiting for the suspects to return. "They soon did, pry bars in hand," the release stated. "The suspects were about to open another room when they must have observed patrol units parked in the area," it added.

They were arrested following a foot chase, and were later identified by witnesses who saw them taking items over a wall, police said.

The property was recovered after the suspects told police where it could be found, the release stated.

Both young men were charged with four counts of burglary and possession of burglary tools.



cial studies teacher because they didn't meet the projected number. They dissolved two social studies classes and three English classes.

"We looked at the numbers all the way around and we found this to be the most efficient way," Fernandez said. An eighth grade teacher will now teach seventh grade social studies and the English department will pick up the English classes, he added.

The principal said class size will go up seven or eight students in the affected subjects.

**Burkholder Junior High School** At Lyal Burkholder, the 1,100 students enrolled is 50 fewer than what the school district projected, and principal Frank Lamping had to release an exploration teacher.

An exploration instructor teachers all three grades. The classes are designed to give the student a broad view of the curriculum. The classes last between four to nine weeks, cover the spectrum of disciplines and are graded on a pass/fail basis.

fourth grade class has 30 students and the school district has allocated a teacher aid for six hours of instructional assistance.

McCaw Elementary School Gordan McCaw was the next closest to meeting the projected figure with 11 students more than the 800 anticipated. The school lost four teachers and this year they have 48 more students, said principal Janet Dobry. They were given back a fourth and fifth grade teacher but Dobry has requested a third grade teacher as well.

Last year the third grade teacher position was not put on the request list. "Right now I am fighting it," Dobry said. "It fell between the cracks. Someone didn't ask for it." The average class size is 33 students, she said.

**Galloway Elementary School** Fay Galloway Elementary School in the Horizon Hills neighborhood picked up two new teachers because its enrollment figure of 804 is 14 more than the school district predicted. A fifth grade instructor and a kindergarten instructor started teaching today.

"This is great because we are able to reduce the class size," said principal Michael Robison. The fifth grade classes will be reduced from 38 students to approximately 30 and the kindergarten classes of 32 will be reduced by seven.

Robison said there will be some problems rearranging students after classes have begun. "This is going to cause some difficulty with the students, teachers and

dents when teaching solely fourth grade.

**Treem Elementary School** Another school that has experienced growth is Harriet Treem **Elementary School in the Whitney** Ranch neighborhood. On count day, the school had 780 students enrolled, which is 124 more than projected, said principal Beverly Daly.

But the school district has some foresight, Daly said because by year's end, the total enrollment figure should be around 800. This is based on the growth in the area.

**Gibson Elementary School** The biggest fluctuation at the primary school level for projection numbers was the James I. Gibson Elementary School. The enrollment figure of 806 is 192 more than predicted.

**Dooley Elementary School** 

Another Henderson school that came very close to meeting the projected number was the John Dooley Elementary School in the River Mountain neighborhood. The 497 students enrolled on count day was eight more than anticipated.

"The number is small enough that it doesn't make too much of a difference," said principal Steward Reid. "We have 21 classes, so the extra numbers aren't dramatic."

The principal added that one a while."

#### **Robert Taylor Elementary School**

Robert Taylor Elementary in the Valley View neighborhood had 12 fewer students on count day than anticipated. Each grade level was very close to the projection, said principal Arturo Ochoa. "We are a tad short in the fifth grade."

The school neither lost nor gained any new teachers. "We're holding our own," Ochoa said. "We were on pins and needles for

parents. But you have to look at the best thing-which is reducing the class size."

**Hinman Elementary School** Edna Hinman Elementary in the Pittman neighborhood lost one teacher after its enrollment figure of 572 students was determined to be 30 fewer than predicted. Principal Dee Leavitt said the school lost a fourth grade teacher and a fourth/fifth grade combination class.

"We had to dissolve the class," Leavitt said. But she added that the combination class teacher will be retaining some of same stu-





OLIVER'S TWIST-Erik Oliver, who replaced injured Wolves







## **MacDonald Ranch on track** for groundbreaking in 1992

MacDonald Ranch, a 3,210-acre masterplanned community in Henderson that will include three luxury resorts, three golf courses and approximately 8,500 home sites, is on track to begin its initial development in the spring of 1992.

Richard C. MacDonald, manager of MacDonald Ranch, said that the engineering studies on the development's first two villages. The Foothills and Sunridge, have been completed and submitted for approval to the city of Henderson.

MacDonald Ranch consists of four masterplanned villages. The project's estimated construction cost is \$1.32 billion. To date, \$4.5 million has been spent on various studies and pre-construction expenditures. A total of \$17 million has been further committed to the development, MacDonald said.

The tentative map for The Foothills at MacDonald Ranch, the project's luxury community, was submitted in early September. Further development awaits final approvals from the city of Henderson and allocation of water to satisfy the needs of the first two villages.

A fiscal impact study on the MacDonald Ranch Project has shown that the first two

villages are expected to bring an estimated \$7 million annually in gross revenues to the city of Henderson.

Located near Lake Mead Drive and U.S. 93/95, MacDonald Ranch is bordered on the south by the McCollough Mountains and will incorporate a variety of the location's natural features into its landscaping, including the desert foothills, ravines, valleys, washes and rock outcroppings. Elevations will range from 2,180 feet to 3,300 feet.

In addition to each of the villages having designated park sites, more than 400 acres of open space within MacDonald Ranch will remain in its natural desert state. Jogging and horseback riding trails will encircle the development.

Production home prices will range from \$110,000 to \$600,000. Custom home lots will start at \$120,000 with the more exclusive sites reaching \$1 million.

Three Palm Springs-style luxury resort/ casinos of 350 to 500 rooms and suites are planned for the project along with three 18hole championship golf courses.

The MacDonald family has been involved in real estate developments in Nevada and Hawaii for more than 25 years.


