Mr. Eckert was invited to speak at the 5th Symposium on Radioactivity in Scandina-via (R.I.S.) held in Helsinki May 18-20. The Symposium is sponsored by the University of Helsinki.

The scientific paper de scribes techniques used to measure radioactive cesium in the muscle tissue of the Alaskan Eskimos. Co-authors with Mr. Eckert are John S. Coogan. health physicist, and Pong N. Lem. chief of data swRHL. This Laboratory is the western radiological health facility of the U.S. Public Health Service's Environ-mental Control Administra-tion, Bureau of Radiological Health.

The Public Health Service has been studying ceshum-137 in the food chain of Alaskan in the tood chain of Alaskan natives since 1965. Measuring radioactive cesium in the Es-kimos, in the caribou they eat, and in the lichen eaten by the caribou is a part of that study. Cesium - 137, a radioactive isotope of cesium found in world - wide fallout, concentrates in the Arctic II. centrates in the Arctic lichen which is a major forage deer, Cesium, whether or not it is radioactive, is found in soft tissue such as muscle and is excreted by the kidneys.

Mr. Eckert is in charge of the project at the SWRHL. He makes periodic visits to 11 re-mote Eskimo villages to make the measurements. Most of the villages can be reached only by dog sied or in planes flown by bush pilots.
