

"They're ours until the lease is up," he said. "They must be moved before that day, and those which are vacant could be sold."

It was learned that CCHA is the only public agency in the state which pays unemployment compensation, 2.7 per cent of the payroli. By rights, public agencies are not obligated to do this.

The CCHA now belongs to the State Employment Act instead of Social Security, and can draw out what they have put into the retirement fund. Cottrell reported that the echa at present has an understanding with the two unions involved in maintaining the housing areas, and he will meet with them about the unemployment insurance.






