THE CLARK COUNTY NEVADA GENEALOGICAL SOCIETY HAS BEEN CHARTERED ONLY SINCE SEPTEMBER, 1976. OUR PURPOSE FOR ORANIZING IS TO BRING TOGETHER THOSE PERSONS INTERESTED IN GENEALOGICAL RESEARCH; TO FURTHER THE PRESERVATION AND ENLARGEMENT OF GENEALOGICAL HISTORY THROUGH INSTRUCTION, WORKSHOPS, AND THIS PUBLICATION. ANYONE INTERESTED IN JOINING OUR SOCIETY IS ENCOURAGED TO DO SO. ANNUAL MEMBER—SHIP FEES ARE \$7.50 WHICH QUALIFIES ONE TO PARTICIPATE IN THE SOCIETY'S WORKSHOPS, LECTURES, AND PROJECTS, AND TO RECEIVE ONE COPY OF THE PROSPECTOR PER QUARTER.

THE PROSPECTOR IS PUBLISHED IN DECEMBER, MARCH, JUNE AND SEPTEMBER. SUBSCRIPTION IS \$8.00 PER YEAR OR \$2.00 PER ISSUE TO NON-MEMBERS. (IT WOULD BE THE KIND OF CHRIST-MAS GIFT WHICH BRINGS YOUR GOOD WISHES THROUGHOUT THE YEAR.)

IT IS OUR INTENTION TO PUBLISH ACCURATE GENEALOGICAL MATERIAL. HOWEVER, WE ASSUME NO RESPONSIBILITY FOR THE ACCURACY OF FACT NOR FOR THE INTERPRETATION OF MATERIAL SUBMITTED BY OUR CONTRIBUTORS.

NEVADA, OUR STATE, HAS SOME CHARACTERISTICS WHICH WE PLAN TO SHARE WITH YOU. WE WILL MENTION NEVADA CEMETERIES AND TELL YOU IF, WHEN, AND HOW MUCH OF EACH ONE HAS HAD GENEALOGICAL WORK PERFORMED, AND PLANS IN PROGRESS CONCERNING FUTURE WORK.

ONE OF THE MAJOR OBJECTIVES OF THIS PUBLICATION IS TO BRING FORTH FROM PRIVATE 'HIDEY—HOLES' INFORMATION FOUND ONLY AT ONE SOURCE, IE., TRANSCRIPTS OF FAMILY BIBLES, CHURCH RECORDS WHICH HAVE FOUND THEIR WAY INTO PLACES MAKING THEM INACCESSIBLE AS PUBLIC INFORMATION, COPIES OF CORRESPONDENCE OF GENEALOGICAL VALUE, ETC. TO THIS END, WE REQUEST YOU TO ASSESS YOUR OWN COLLECTION OF DOCUMENTSS AS POSSIBLE CANDIDATES FOR OUR PAPER.

"SKI-T-TOOK, I.T., MARCH 21, 1897

MY DEAR SISTER SALLIE: YESTERDAY AT NOON WHILE ON THE WAY FROM OKLA HERE, I REC'D A CARD FROM BROTHER CHARLEY BEARING THE SAD, SAD NEWS OF THE DEATH OF OUR LOVED BROTHER WILLIE.

I EXPECT YOU HAVE HEARD IT BEFORE THIS, AND I KNOW HOW YOU ARE GREIVED, BUT DEAR SISTER, SAD AS IT IS, WE MUST BEAR OUR SORROW AND IT IS THE GREATEST WE HAVE EVER HAD. I KNOW OUR DEAR FATHER AND MOTHER MUST FEEL THIS SORROW GREATER THAN WE POSSIBLY CAN, HOW I WISH WE COULD BE WITH THEM, (UNINTELLIGIBLE) I HAVE BEEN THINKING SO MUCH OF BERTHA, I KNOW SHE IS A GOOD TRUE WOMAN, AND DEAR LITTLE ASENATH.

YOU HAVE OR WILL HEAR FROM HOME SOON. I ONLY REC'D A CARD AND I AM SO ANXIOUS TO HEAR MORE. I SUPPOSE THIS SORROW IS SENT UPON US ALL FOR SOME GOOD PURPOSE, OUR DEAR BROTHER WAS SO ANXIOUS TO HAVE A GOOD STANDING AT MARCH EXAM AND I EXPECT HE HAS (SIC) OVERWORKED HIMSELF SOME. CHARLEY SAID THE DRS. OF THE COLLEGE ATTENDED HIM BUT NOTHING COULD POSSIBLY SAVE HIM.

DEAR SISTER I'VE THOUGHT OF WRITING TO YOU SO MANY TIMES, TO KNOW HOW YOU ALL WERE. I WAS SURPRISED TO HEAR OF YOU BEING IN LA. I HOPE YOU WILL LIKE YOUR NEW HOME, AND I KNOW FRANK WILL ENJOY BEING WITH HIS BROTHERS, AND IT MAY BE A GOOD MOVE FOR YOU, BUT YOU MUST BE VERY CAREFUL OF YOUR HEALTH ALL OF YOU, MOVING TO A NEW COUNTRY, YOU WILL HAVE TO GET ACCLIMATED. I HAD A LETTER FROM "MA" WRITTEN MARCH 2^{ND} , SHE SAID DEAR LITTLE VERNA DIDN'T WANT TO GO TO LA, SEEMINGLY. I WOULD LIKE TO COME TO SEE YOU (PAGE 2) BUT I CAN NOT THIS SUMMER, I THINK I OUGHT TO GO TO OHIO. I WANT TO SEE THEM ALL SO MUCH, AND I COULD BE WITH FREDDIE AND MARY MORE. I MAY GO IN A MONTH OR NOT UNTIL JULY 1^{ST} .

I HAVE RENTED MY PLACE BUT OF COURSE I CAN NOT BE OFF OF IT ONLY 6 MONS. AT A TIME, IF I GO TO OHIO SOON I WILL RETURN IN SEPT. OR OCT. AND TEACH IN OKLA. NEXT WINTER.

I GOT ALONG QUITE WELL WITH MY OKLA. SCHOOL, ONLY TERM TO (SIC) SHORT, AND NOT ENOUGH SALARY THEY HAVE OFFERED ME THE SCHOOL AGAIN, AND I HAVE A GOOD PROSPECTS (SIC) FOR SITUATIONS.

CONTINUATION OF LETTER FROM ANNA KELLOUGH TO MRS. FRANK RADER:

I JUST REACHED SKI-A-TOOK TODAY AND WILL BE MATRON HERE 3 MONTHS UNLESS I THINK BEST TO GO TO OHIO SOONER.

I SUPPOSE YOU KNOW OUR BROTHER J. PAUL WAS TO BE MARRIED M^{ch} 11 TO MISS IVY WOOD. I MET HER IN OHIO SHE IS A BRIGHT GIRL, BELONGS TO SPLENDID FAMILY.

I WILL BE SO GLAD TO HEAR FRCM YOU SOON AS CONVENIENT, NOW YOU SEEM SO FAR AWAY FROM HOME. YOU MUST TAKE GOOD CARE OF YOUR HEALTH SISTER, FOR HEALTH IS THE GREATEST BLESSING, NOTHING TO BE COMPARED TO IT. TELL FRANK I WISH HIM SO MUCH SUCCESS IN HIS NEW HOME. I'D LOVE TO SEE YOU ALL, LET ME KNOW HOW YOU ALL ARE WHEN YOU WRITE, LOVE TO ALL.
