| Capital Construction Fund | \$ (41,000) | \$ 41,000 | The District budgeted \$130,000 in Supplies & Services for the repair and maintanence of library facilities. It was determined that the replacement of lobby flooring at the Paseo Verde Library was necessary and that some of the budgeted funds should be used for this purpose. Flooring would be considered a capital outlay, not a repair, therefore, a transfer was done to move appropriations from Supplies & Services to Capital Outlays. |
